

Trade Measures (Fees) Regulations, 2020

---

IT is hereby notified that the Minister of Industry and Commerce, after consultation with the Minister of Finance, has, in terms of section 32 of the Trade Measures Act [Chapter 14:23], made the following regulations: —

*Title*

1. These regulations may be cited as Trade Measures (Fees) Regulations, 2020.

*Interpretation*

2. In these regulations—

“special applicant” means a person who, not having been called upon by an inspector to submit measuring equipment for re-assizing in terms of the Act, notifies an inspector of the particulars of any measuring equipment and the place where it is kept, and requests that such measuring equipment be assized or re-assized at that place.

*Fees in respect of assizing, re-assizing or rejection of measuring equipment*

3. There shall be charged in respect of assizing, re-assizing or rejection of measuring equipment the fees prescribed in the First Schedule.

*Fees to be charged in respect of services provided*

4. There shall be charged in respect of the services specified in the first column of the Second Schedule, the fees specified opposite thereto in the second column of the Second Schedule.

*Fees in respect of inspector attending to special applicant*

5. Where an inspector tests measuring equipment on the premises of a special applicant, there shall be charged, in respect of each journey necessarily made by the inspector to the premises, the actual costs incurred by the Government in transporting and detaining the inspector and the official equipment necessary to carry out the tests, in addition to any fees charged in terms of section 3 or 4:

Provided that where one journey is made to test the measuring equipment on the premises of two or more special applicants, each

special applicant shall be charged such proportion, of the cost of transport as the Minister may determine.

*Circumstances in which fee may be increased*

6. Where an inspector is of the opinion that he or she has not been rendered sufficient assistance to enable him or her to assize or re-assize measuring equipment expeditiously, the appropriate fee chargeable in terms of section 3 shall be increased by fifty *per centum* (50%).

*Fee in respect of rejected equipment*

7. Where a person requires that equipment which he or she has repaired or installed be assized, and such equipment is rejected, the person shall be charged the fee chargeable in terms of section 3 or 4.

*Penalty for non-payment of fees*

8. Any person who fails or refuses to pay any chargeable fees in terms of these regulations shall be guilty of an offence and liable to a fine not exceeding level 4 or imprisonment for a period not exceeding three months, or to both such fine and such imprisonment.

*Repeal*

9. The Trade Measures (Fees) Regulations, 2010, published in Statutory Instrument 103 of 2010, are repealed.
